*Description of Services:*

- 1 hour-long engagement session
- 80+ edited photos from engagement session, delivered within 5 business days
- Logistics meeting with Cecily that occurs 4-8 weeks in advance of the wedding to talk through expectations, schedule, and shot list.
- 7 consecutive hours of wedding day coverage by Cecily
- 25+ sneak peek photos delivered 24 hours after the wedding is over
- 500+ final edited photos from wedding day delivered within 5 business days
- unlimited downloads and printing rights

### *Payment Instructions:*

50% BOOKING FEE:	\$1,450.00
REMAINDER DUE 7 DAYS AFTER THE WEDDING	\$1,450.00

Once this contract is signed and Cecily receives the 50% booking fee, your wedding date is reserved in her calendar. The remaining 50% is due by 7 days after the wedding. Cecily Breeding Creative accepts payment via check in the mail or in person, Venmo, Apple Pay, or cash. If you prefer to pay with a credit card, please notify Cecily and she will send you a PayPal invoice, which can be paid with a credit card. *Please note, a PayPal invoice will incur a 3% service charge.*

### *Disasters, Refunds & Cancellations:*

In the event that Cecily becomes ill or injured or is otherwise unable to complete all the services as listed in the "Description of Service" section, one of the following courses of action are available, at the client's discretion:

1. Second photographer fill in. If there is a second photographer listed in the "Description of Service" section, the second photographer will perform the photography on his/her own. Cecily will edit the second photographer's photos to her usual standards. In this case, a refund of \$150/hour will be issued to the client for every hour Cecily missed.
2. Replacement photographer. If there is no second photographer, Cecily will find a replacement photographer to perform the photography. Cecily will edit the replacement photographer's photos to her usual standards. In this case, no additional charges or refunds will be issued.
3. Full refund. If no replacement photographer can be found, or if the ones found are not acceptable to the client, the client is entitled to a full refund of the fees paid for the service. In this case, Cecily and any second or replacement photographers are released from providing photography services.

In the event that the client cancels the wedding photography for any reason, the client is entitled to the following percentage of the booking fee:

1. Cancellation 6 months or more before the wedding day: 75% refund
2. Cancellation 1 to 6 months before the wedding day: 50% refund
3. Cancellation less than 1 month before the wedding day: no refund

### *Deliverable & Usage:*

Cecily Breeding Creative distributes all full-resolution photo files via a Pixieset online gallery. Once the photos are uploaded to the online gallery, Cecily will send an email

invitation with a link to view all the images in the folder. Anyone with the link can view and download the full-resolution photos. Cecily will leave the photo gallery online for 6 months after the wedding, to give ample time for anyone who wants the files to download them. After 6 months, Cecily will remove them from the gallery but still keep the files forever on her external hard drives. *Please note: disasters can happen, even with digital files, so it's best to download all the images to a couple locations.*

Cecily will be taking LOTS of photos during the day. Not every photo Cecily takes will wind up in the online gallery. That would be overwhelming to click through 2000+ photos (many of them doubles)! Instead Cecily culls the photos she takes down to the very best images, edits them to perfection, and loads those to the online gallery. The number of final images is listed in the "Description of Services" section of this contract.

The client is in control of his/her own printing process.
